

ORDER

As per the notification cited (1), University invited applications for Continuation of Provisional Affiliation for the academic year 2021-22 from colleges for courses affiliated to the University. The Principals of Pharmacy colleges mentioned in Para (5) below have submitted the application and remitted required fee for Continuation of Provisional Affiliation for the year 2021-22.

- 2. Considering the situations due to covid19 pandemic, Governing Council vide decision cited (2), decided to give one time exemption to the colleges satisfying any of the following conditions, from inspection for the grant of Continuation of Provisional Affiliation for the academic year 2021-22.
- i. The colleges whose first batch of all courses are passed out and no major/minor deficiencies were pointed out during inspection conducted for the grant of continuation of provisional affiliation during the academic year 2019-20 and inspections were not conducted for the grant of continuation of provisional affiliation during 2020-21.
- ii. The colleges whose first batch of all courses are passed out and no major deficiencies, but with minor deficiencies/no deficiencies were pointed out during inspection conducted for the grant of continuation of provisional affiliation during the academic year 2020-21.
- iii. The colleges which will satisfy any of the above two conditions, if exempting the norm that the first batch of the students of all courses admitted in the college under EWS quota in various UG, PG courses and /or under super speciality courses(starting/enhancement of seats) were passed out.
- 3. Hence inspection is not required in the following Pharmacy colleges for the grant of Continuation of Provisional Affiliation for the year 2021-22. 

- 2. The Governing Council vide read (2) above decided to conduct inspections for granting continuation of provisional affiliation in every two years in all colleges except those colleges where first batch of U.G/P.G/Super specialty courses has not passed out. Since inspection was conducted in these colleges last year, this year the same was not conducted in accordance with the above GC decision.
- 3. The matter of granting Continuation of Provisional Affiliation to these colleges was placed before the 58th Governing Council held on 23/12/2019. The Governing Council vide decision read (3) above decided to grant continuation of provisional affiliation to these Colleges as mentioned in para 5 below with courses and annual intake mentioned against each, for the academic year 2020–21 without conducting inspection based on decision no.23.19 of the Governing Council, subject to receipt of renewal permission from AICTE and PCI.
- 4. Vide orders read (4) above, Hon'ble Supreme Court of India stated that Pharmacy Council of India is the authority to regulate the Pharmacy education in India. In compliance of the Hon'ble Supreme Court, AICTE has notified that their approvals are not mandatory for the conduct of Pharmacy institutes. Now, all the Colleges mentioned below have submitted renewal permission from PCI for the Academic Year 2020–21. As stipulated in Chapter XXI of First Statutes of the University, the Colleges have constituted College Council.
- 5. - 2. Applications were processed by the University and inspections were conducted at the Colleges. The reports submitted by the Inspection Commission were verified by the Scrutiny Committee. The deficiencies pointed out by the Committee were intimated to the Colleges and the Colleges have furnished Compliance reports rectifying of deficiencies. After verification of the inspection report, the Scrutiny Committee recommended to grant Continuation of Provisional Affiliation to the Colleges for the Year 2019-2020.
- 3. The whole matter was placed before the Governing Council. The Governing Council vide papers read (2),(3)&(4) above has decided to grant Continuation of Provisional Affiliation to the Pharmacy Colleges for the Academic year 2019-20 based on recommendations of Scrutiny Committee, subject to receipt of renewal permission from AICTE and PCI.
- 4. All the Colleges have submitted renewal permission from AICTE and PCI for the Academic Year 2019-20. As stipulated in Chapter XXI of First Statutes of the University the Colleges have constituted College Council.
- 5.
