2. MTM (Medication therapy management) center-Telehealth center is something new and different that I found in Findlay. MTM is supported by three full time staff and several other part-time pharmacists, Findlay students work with patients over the phone or video messaging to assess their medication regimen and lifestyle factors and look for any conflicting medicines. Through this process, students improve their proficiency in patient communication. On the medication side, students work with cases that contain medication conflicts and will experience the steps pharmacist take to reconcile the issues.

I also got a chance to visit Hospice nearby Wyandot memorial hospital. Hospice care is offered and provided for patients during last phase of an incurable illness or near the end of life, such as in some people with advanced or metastatic cancer. Treatment during Hospice care involves managing symptoms and side-effects. Our role in hospice care involves assessing the appropriateness of medication orders for patients,

ensuring timely provision of effective medications for symptom control and management, counseling and educating the hospice team about supportive care through the use of medication therapy, and ensuring that patient and caregivers understand and adhere to the directions provided with medications.
