Your seat will be confirmed subject to availability of seats in your program at the time of your payment. To hold your place, the fee of C\$16349.74 must be received by the "deadline date" mentioned above. Payment should be made in Canadian dollars through Flywire ONLY. The fee receipt can be downloaded from your Flywire account approximately 48-72 hours after making the payment.

Arrival Services are provided at no additional charge to all new international students. This includes pre-departure briefings, transportation from Pearson Airport to London (or a Fanshawe regional campus), and preferred rates at Fanshawe partner hotels.


