Our OT is equipped with Higher end Anesthesia work stations, KARL STORZ, RICHARD WOLF Laparoscopic sets. Our Scanning department equipped with 9 Ultrasound color Doppler machines. Our 50 bedded tertiary level NICU equipped with Five Dragger Baby Log Ventilators, one Dragger VN 500 high frequency Ventilator, Seven F & P Bubble C- PAP, eighteen single surface & Four Double surface phototherapy units and 40 warmers which caters more than 250 Patients per month. Our IVF unit serves an average of 100 patients per day.
